I agree to release, discharge, waive and indemnify the Eco-Justice Center, and its members and volunteers, from any claims or allegations based upon or arising out of actions of my child or the conduct of other persons. I understand that the Eco-Justice Center reserves the right to withdraw a child from the program, at the Eco-Justice Center's discretion, if the enrollment of the child negatively affects the integrity of the program. I also grant permission for my child to travel to the neighboring Cliffside County Park with staff/volunteers while attending camp.

In the event parents/guardians listed on this form cannot be reached in an emergency, I authorize the Eco-Justice Center staff/volunteers to render first aid, and give permission to the physician selected by the Eco-Justice Center to hospitalize, secure proper treatment for, and to order injections, anesthesia, or surgery for my child. Prudent attempts will be made to contact the parents/guardians immediately.
